Each entry must be submitted in accordance with these terms and conditions and by entering the competition, the entrant agrees to be bound by these terms and conditions. There is no cost to the entrant to enter.

Dates

- Entries will be accepted until 5:00PM 8th October 2021. No entries will be accepted after this time.
- The decision will be announced on 15th October 2021
- Winning entrants will be notified by email at 1:00PM on 15th October 2021.

Requirements of Entry

- Entries must be submitted electronically via email to realestate@gdlrural.com.au or can be given to any branch on DVD, CD or USB.
- There are no age restrictions on entry, and entry is **NOT** open to employees of Nutrien Harcourts GDL or GDL
- The Judges and their family members are ineligible to enter.
- Entries must contain the following information:

» *Entrant's full name*

» *Entrant's postal address, email address and preferred telephone contact number*

- Each entrant can submit a maximum of 10 entries.

Technical requirements:

- » Photographs can be submitted in a range of digital formats (eg. JPEG, TIFF) but must be high resolution
- » Photographs should not be downsized or compressed for email.
- » Photographs may be edited, prior to entry only, to adjust 'errors' in composition, exposure, brightness and contrast, however content must not be removed, added, altered or distorted beyond the truth of the original photograph.
- » Alterations permitted in the competition include:

Cropping

- Rotation e.g. to straighten a crooked horizon
- Adjustments to brightness and contrast
- Minimal sharpening and softening
- Conversion from colour to black and white (i.e. total desaturation)
- Removal of sensor dust

Judging Criteria

- Each entry will be judged by Emily Gale Real Property Photography Toowoomba
- Each entry will be individually judged according to its merits on the basis of originality and creativity as determined

Content

- By submitting an entry to the competition, each entrant warrants and agrees that:
 - he/she has obtained prior consent to be depicted in the entry, from any person or property appearing in the image;
 - he/she has obtained prior consent to be depicted in the entry, from the legal parent/guardian of any minor appearing in the image;
 - he/she has obtained full prior consent from any person who has jointly created or has any rights in the image, to the uses and terms herein;
 - he/she is the legal owner of the image they submit; and
 - he/she indemnifies Nutrien Harcourts GDL, to the full extent permitted by law, against any loss arising out of the use of the image in association with the competition's rules.
